

## Gifts via Stock and Wire: Transfer Instructions

For all stock gifts and wire transfers, please use the attached Ronald McDonald House Charities Bay Area Transfer Instruction Letter. In order to properly acknowledge your gift and ensure the correct donor is credited for the gift, please notify us of the transfer. Please state the purpose of your gift and an address to send a gift acknowledgement.

The value of your stock gift is determined by taking the mean of the high and the low value of the security on the day that it is credited to the RMHC Bay Area account or the day that the certificate is in the custody of the Charities with a gift letter and an executed stock power. If mailed through the U.S. Postal Service, the gift value is established on the date of the postmark. RMHC Bay Area's Federal Tax ID Number is 94-2538615.

Attached is a letter you may use to send directly to your broker or bank trust officer with your gifting instructions. If you wish to gift a stock certificate rather than have your bank or broker deliver the stock electronically, please have the certificate registered in the name of "Goldman, Sachs & Co. LLC. as custodian, fbo Ronald McDonald House Charities Bay Area", as specified on the attached form. *Please send or fax a copy of your transfer authorization to the Charities at the address below so we may expect your gift.* 

If the certificate is registered in your name, send it to the Charities *unsigned*, along with a letter confirming the gift to RMHC Bay Area. You will want to include the specific purpose of the gift. Send a signed stock power in a separate envelope. Stock powers must be signed as the name(s) appear on the stock certificates.
